Representatives from the Group attend the Association's meetings to fulfil its obligation as a member, and for mutual respect and exchange of industry views. The Group, however, does not participate or get involved in the respective decision making and execution thereof by the Association. The Association does not participate or get involved in the decision making of the Group's operations either.
- 4. The Group does not adhere to any of the Association's pricing guidelines, and as such did not submit any "acknowledgement report".

5. The Group always complies with all relevant laws and regulations, and will continue to abide by this principle in the operation of its business.
